EPSON AMERICA, INC. LIMITED WARRANTY

What is Covered: Epson America, Inc. ("Epson") warrants to the first end user customer of the Epson product covered by this limited warranty statement that the product, if purchased and used in the United States, Canada or Puerto Rico, conforms to the manufacturer's specifications and will be free from defects in workmanship and materials for a period of one (1) year from the date of original purchase. Epson warrants that the Epson product is manufactured from new components and parts, or from like-new components and parts which perform like new and meet the Epson standard of quality. For warranty service, you must provide proof of the date of original purchase. Epson also warrants that the consumable ink cartridges, if enclosed with the product, will perform to the manufacturer's specified usage, which usage may expire before the expiration of the one year limited warranty for the printer.

What Epson Will Do To Correct Problems: Should your Epson product prove defective during the warranty period, please send the product, securely packaged in its original container or an equivalent, along with proof of the date of original purchase, to Epson or an Epson Authorized Servicer. The servicer will, at Epson's option, either repair the defective unit, or replace it on an exchange basis, without charge for parts or labor. If Epson repairs the printer, you are responsible for packing the defective unit, and for all costs of sending the defective unit to the servicer and sending the repaired or replacement unit back to you. If the servicer exchanges the product for you, you are responsible for securely packaging the defective unit and returning it to Epson within five (5) working days of receipt of the replacement. Epson requires a debit or a credit card number to secure the cost of the replacement printer in case you fail to return the defective unit in time. When warranty service involves the exchange of the product or of a part, the item replaced becomes Epson property. The exchanged product or part may be new or previously repaired to the Epson standard of quality. Exchange or replacement products or parts assume the remaining warranty period of the product covered by this limited warranty.

What This Warranty Does Not Cover:

This warranty does not cover:

- 1. Damage from use of the product outside the United States, Canada, or Puerto Rico.
- 2. Damage caused by the addition of third-party parts, components, consumables, or peripheral devices added to the product after its shipment from Epson (e.g. dealer-added boards, chips or drives).
- 3. Damage caused by using non-Epson inks or ink cartridges, or any ink delivery system other than the system built into the printer (for example, any bulk ink system), or caused by using unsuitable media.
- Any damage from service performed by other than Epson or an Epson Authorized Servicer.
- 5. Service where the printer label, logo, rating label, or serial number has been removed.
- Any damage caused by using improper packaging materials or improper packaging and shipping.
- 7. Any damage caused by misuse, abuse (for example damage caused by liquid, excessive dust, harsh environments, or dropping the product), improper installation, neglect, failure to maintain, improper packing or shipping, disasters such as fire, flood, lightning, improper electrical currents, software problems, or interaction with non-Epson products.
- Postage, insurance, or shipping costs incurred in presenting the product for warranty service.
- 9. Any color change or fading of prints, or reimbursement of materials or services required for reprinting.

If a claimed defect cannot be identified or reproduced in service, you will be held responsible for costs incurred.

Some jurisdictions do not allow limits on warranties or remedies for breach in certain transactions. In such jurisdictions, the limits in this paragraph and the preceding paragraph may not apply.

Arbitration, Governing Laws: Any disputes arising out of this Agreement will be settled by arbitration to be conducted in Los Angeles, California, in accordance with the commercial Arbitration Rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. This Agreement shall be construed in accordance with the laws of the State of California, except this arbitration clause which shall be construed in accordance with the Federal Arbitration Act.
